With the Lone Peak Pass lift ticket, you can access 5,512 skiable acres and endless ways to navigate 4,350 feet of vertical drop. Runs up to six miles long and glades and bowls covered in 400~plus inches of annual snowfall make a day on the slopes something different for everyone

- **DATES:** January 13 – 18, 2010 (Martin Luther King Weekend). This is one of the MAIN ski weekends so reservations and travel arrangements **MUST** be made **EARLY!**
- **SKIING:** GREAT!!! Big Sky offers instant access some of the most diverse skiing and snow-boarding in the lower 48. The Big Sky Resort-Moonlight Basin interconnect gives you access to more skiing than anywhere else in the United States. You'll find almost twice as many acres as skiers.
- **LODGING:** We're holding an assortment of units (descriptions enclosed). The number of each type is limited so be sure to reserve your preferred type early. The prices include **5 nights accommodations** and current taxes. Subject to availability, **Big Sky** will offer the same daily rates for those wanting to come early or stay longer.
- **TRAVEL:** Big Sky is very accessible. More than 25 flights a day arrive into Bozeman, Montana on several major airlines, including Northwest, Delta/Sky West, and United/United Express. Big Sky is only a 45 minute ride from Bozeman. You can rent a car or take one of many various shuttle services which run regularly between the airport and the resort.
